WE, the undersigned registered electors of the Sweetwater Union High School District, in accordance with the provisions of section 5019 et seq. of the Education Code of the State of California, do hereby petition the County Board of Education, acting as the County Committee on School District Organization, for the establishment of trustee areas in said district and an alternate method of election of governing board members in accordance with Education Code section 5030 as described below:

Each governing board member shall be elected by the registered voters of the entire school district, but shall reside in the trustee area which he or she represents.

There shall be one board member elected for each trustee area. The population of each trustee area shall approximate the same proportion of the total population of the district as each of the other trustee areas. The County Superintendent of Schools shall prepare and keep in his or her office a map showing the boundaries of such trustee areas, in accordance with Education Code section 5031. This petition is borne out of a community belief that school board members should be accessible to their constituents and representative of the many diverse neighborhoods which comprise the Sweetwater Union High School District.

For the purpose of receiving notice of any public hearings to be held on this petition, the following petitioners are designated as "chief petitioners:"
